Scholarship Details

PURPOSE:

In order to carry on an educational and training program that encourages Ohio's rural youth to further their education and gives them an opportunity to become more aware of careers in the rural electric program, the Children of Members scholarship awards program is offered by North Western Electric Cooperative, Inc. (NWEC) and Ohio's Electric Cooperatives, Inc. (OEC).

AWARDS: DIVISION 1 - BOYS DIVISION II - GIRLS

The local cash scholarship awards for each division are: First place - \$1500, second place - \$750

One local first place winner of this scholarship will be named as the overall winner and will advance to the statewide level where they will compete for additional cash.

INTERVIEWS

Local interviews will be held on March 6, 2024 at Defiance College and all eligible applicants are required to participate on that day in order to be considered for the scholarship award. Additional information will be mailed to the applicants prior to that date regarding specific interview times.

The local overall winner **must be available to interview on April 16, 2024 in Columbus, OH** for a chance to win an additional award.

	An official, signed grade transcript Applicants must have a cumulative grade point average of 3.5 or above on a 4.0 scale or an equivalent standing on a nontraditional scale.			
	One letter of recommendation The letter may be typed or handwritten and must be no longer than 500 words.			
	A recent photo of the applicant - A photocopy of a photo is acceptable.

Scholarship Rules

The following provisions will govern the acceptance of applicants for the Children of Members Scholarship:

- Applicants must be the son, daughter, or <u>legal</u> ward of a permanent <u>residential</u> NWEC memberowner receiving service for the duration of the 2023-2024 academic year (August 2023 - June 2024). Children/wards of NWEC <u>commercial</u> member-owners are not eligible unless one of their parents/legal guardians is also a permanent <u>residential</u> NWEC member-owner.
- Applicants must be graduating seniors who have all basic credits for college or proper vocational or technical school entrance. A "proper vocational or technical school" is defined as a post-secondary institution where credits can be transferred to a state accredited four-year college.
- 3. Applicants must have a cumulative grade point average of <u>3.5 or above</u> on a 4.0 scale or an equivalent standing on a nontraditional scale.
- 4. Winners must provide proof of enrollment in an accredited college or proper vocational/technical school of students' choice to claim their scholarship. Winners who are accepted and then enrolled in an accredited school of nursing, working toward a degree, are also eligible.
- Students may not be immediate family members of, or reside with, people who are employed by any
 electric cooperative in Ohio (employees, trustees, managers, OEC, or affiliated organizations such as
 Buckeye Power, Inc., RESCO, etc.).
- 6. Applicants who receive "full-ride" scholarships (i.e., scholarships that cover the cost of tuition, room, board *and* books) to the schools of their choice are **not eligible** for scholarships from NWEC or OEC.
- 7. All scholarships must be accepted in the first academic year following the student's high school graduation. However, an extension of one year may be granted for just cause in the judgment of the President/CEO of NWEC or of OEC. In the event students are unable to fulfill their enrollment obligation under this program, the awards are forfeited.
- 8. These rules supersede all previous rules for this scholarship.
