## Agriculture Program Rebate Agreement

July 1, 2021 – June 30, 2022

It is the joint interest of North Western Electric Cooperative (NVEC) and its members to promote the value of energy efficiency to agricultural business members through offering funds for specific energy efficient equipment purchase and installation unique to the agricultural industry.

### Eligible Equipment Specifications

- **Engine Block Heater with Timer:**  
Rebate when installing new engine block heater with a timer. Rebate per new engine block heater with a timer is \$20 per engine block heater with timer and may not exceed 50% of equipment cost.
- **High Volume, Low Speed (HVLS) Fans**  
Rebate when installing new properly sized HVLS fan in place of numerous small fans in an open barn or similar setting. Rebate calculated at \$30 per foot of HVLS fan diameter and may not exceed 50% of equipment cost.
- **Well Water Milk Pre-Cooler System (Dairy)**  
Rebate when installing new well-water milk pre-cooling system (plate cooler) prior to the refrigeration/cooling process on a dairy farm. Rebate per new well-water milk pre-cooling system (plate cooler) is \$500 per pre-cooling unit/exchanger and may not exceed 50% of equipment cost.
- **Variable Speed Drive (VSD) Vacuum Pump (Dairy)**  
Rebate when installing a variable speed drive (VSD) milk vacuum pump in the milking process. A milk pre-cooling system (plate cooler) must be present to receive VSD vacuum pump rebate. Rebate calculated at \$40 per horsepower (HP) of VSD vacuum pump and may not exceed 50% of equipment cost.
- **Variable Speed Drive (VSD) Milk Transfer Pump (Dairy)**  
Rebate when installing new variable speed drive (VSD) milk transfer pump in the milking process. Rebate calculated at \$40 per horsepower (HP) of transfer pump and may not exceed 50% of equipment cost.

- **Swine Farrowing Heat Mat (Hogs)**

Rebate when installing new swine farrowing electric heat mat in place of higher wattage heat lamps. Rebate calculated at \$50 per unit/mat for a single mat or \$75 per unit/mat for a double (two stalls shared) mat and may not exceed 50% of equipment cost.

### **Conditions of Rebate**

- All equipment must be new. Used or rebuilt equipment is not eligible.
- Equipment must be installed at an agricultural facility which receives its electric power from NWECC.
- **Purchase and installation must be between July 1, 2021 and June 30, 2022.** Purchase or installation prior to July 1, 2021, is not eligible.
- **Labor and/or installation costs are not eligible for rebate** and are not to be included as part of equipment cost submitted.
- Rebate is paid as a one-time, one-program offer and cannot be combined with other programs for additional funding of equipment.
- Rebate may not exceed 50% of equipment cost (excluding labor), up to a total maximum rebate amount of \$5,000 per rebate application.

### **Rebate Requirements**

- Rebate is to be issued to the Cooperative member; the rebate cannot be paid to a builder/dealer.
- **A rebate request form and proof of purchase must be submitted to NWECC within 60 days of the purchase of the appliance.**
- Only one Agricultural Program rebate will be granted per agricultural business member per fiscal year (July 1 – June 30).
